## ORDER GRANTING MOTION FOR EXTENSION OF TIME

On July 28, 2025, The Empire District Electric Company d/b/a Liberty filed a motion asking the Commission to extend the previously granted approval of Liberty's membership in the Southwest Power Pool (SPP) until all transmission facilities identified in the 2024 Integrated Transmission Plan (ITP) are placed into service by the above-referenced application. As requested by the Office of the Public Counsel (OPC) and the Staff of the Commission (Staff), the Commission granted interim approval for Liberty to remain in SPP until October 1, 2025. The Commission further ordered that any party who wished to respond to Liberty's original motion should do so no later than August 20, 2025.

On August 20, 2025, OPC and Staff filed a Motion for Extension of Time. The movants state that given the press of business, they need until September 12, 2025, to respond.

The Commission finds the motion reasonable, and will grant it.

### THE COMMISSION ORDERS THAT:

1. The Motion for Extension of Time is granted.

2. OPC and Staff shall respond to Liberty's July 28, 2025 motion no later than September 12, 2025.

3. This order shall be effective when issued.
