## NOTICE EXCUSING APPEARANCE

Issue Date: August 21, 2025

On August 20, 2025, the Commission held a prehearing conference via WebEx. Bobby J. Armour (Complainant) did not appear for the August 20, 2025, prehearing conference and did not contact the Commission to request a continuance. Further, the order setting the prehearing conference stated that failure to participate in the prehearing conference may result in dismissal of this case.

After the prehearing conference adjourned, Mr. Armour communicated with the Presiding Judge's clerk to state that he had missed the prehearing conference due to his meeting with an attorney. Because of his handwritten note on a prior filing that he will transmit a letter to counsel,<sup>1</sup> the Commission is also led to understand that Complainant has retained counsel. To date, no counsel has entered their appearance for the Complainant.

On its own motion, the Commission will excuse Mr. Armour's attendance at the August 20, 2025, prehearing conference. However, if the Complainant is represented in
