**NOTICE REGARDING REVISED TARIFF SHEETS**

Issue Date: April 6, 2017

On March 8, 2017, Kansas City Power and Light Company and KCP&L Greater Missouri Operations Company (collectively, the "Company") filed revised tariff sheets (Tariff Tracking Nos. YE-2017-0172 and YE-2017-0171, respectively) to remove incorrect references to Commission rule 4 CSR 240-20.094(4) and correct a typographical error. The revised tariff sheets, which were subsequently substituted, carry an effective date of April 7, 2017.

The Commission's Staff has reviewed the revised tariff sheets and recommends that the Commission approve them. Staff has verified that the Company has filed its 2015 annual reports and is not delinquent on any assessment. However, if the Commission were to issue an order approving the revised tariff sheets, that order would not have the required ten days prior to April 7, 2017 for such an order to become

effective.<sup>1</sup> Therefore, since the Commission finds that the revised tariff sheets are compliant with all applicable statutes and regulations, the Commission will allow the revised tariff sheets in Tariff Tracking Nos. YE-2017-0172 and YE-2017-0171, as substituted, to become effective on April 7, 2017 by operation of law.

App. 2013), stating that “any shortening of the date on which PSC orders will become effective to less than ten days is presumptively unreasonable and, if challenged, would require the PSC to demonstrate that the circumstances surrounding the case are so extraordinary as to clearly warrant further encroachment on the time provided to the parties in which to exercise their right to apply for rehearing and/or appeal and that the time allowed was reasonably sufficient.”
