## ORDER SCHEDULING LOCAL PUBLIC HEARING AND DIRECTING NOTICE

On August 6, 2025, Raytown Water Company (Raytown) filed its *Amended Notice of Rate Increase* in a Staff assisted rate case. Commission Rule 20 CSR 4240-10.075(6) requires a local public hearing to be scheduled to occur no later than 60 days after the opening of the case, unless all parties agree that a local public hearing is not necessary. The Commission will schedule a local public hearing in compliance with the Commission Rule. The Commission will direct written comments to be submitted to the Commission's Electronic Filing and Information System (EFIS).

### THE COMMISSION ORDERS THAT:

1. A local public hearing is scheduled to begin at **6 p.m.** on **September 22, 2025**, at the Knights of Columbus Hall, 5101 Blue Ridge Parkway, Kansas City, MO 64133.
2. The Commission's Public Policy and Outreach Department shall make an informal presentation and conduct a question-and-answer session for the public at the beginning of the local public hearing. Comments to the Commission from the public will begin at the conclusion of the question and answer session.
3. Raytown, the Staff of the Missouri Public Service Commission, and the Office of the Public Counsel shall make a representative available to address substantive

issues during the question-and-answer sessions. Any other party may also choose to have a representative present.

4. No later than ten days before the local public hearing, the Company shall provide notice of the hearing to each of its customers.

5. Any person may comment at the hearing. However, comments may be limited to three minutes if a large number of attendees will be commenting.

6. Comments may also be submitted to the Commission in writing. When submitting comments please reference Case No. WR-2025-0294. Submit comments:

8. The Commission's Public Policy and Outreach Department shall make notice of this order available to the members of the media and the General Assembly representing customers in Raytown's service area.

9. The Commission's Data Center shall provide a copy of this order to the county commission for each county in the Raytown's service area.

10. This order shall be effective when issued.
