## ORDER DIRECTING FILING

On January 17, 2025, Evergy Metro, Inc., d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc., d/b/a Evergy Missouri West (the Companies) filed a request for a variance of Various Chapter 13 Regulations. The Commission issued an Order Approving Stipulation and Agreement on August 13, 2025 with an effective date of September 12, 2025.

To comply with the Commission's August 13, 2025 order, the Companies filed Tariff No. JE-2025-0016 on August 20, 2025. The tariff bears an effective date of September 19, 2025. However, the Companies filed a Motion for Expedited Treatment in which they asked for approval of the tariffs by August 28, 2025. The Companies represent that Staff does not object. The Commission will allow parties to respond.

### THE COMMISSION ORDERS THAT:

1. Any party who wishes to respond to the tariff shall do so no later than August 27, 2025.

2. This order shall be effective when issued.
