**STATUS REPORT**

**COMES NOW**, Evergy Missouri West, Inc. d/b/a Evergy Missouri West ("Evergy Missouri West" or the "Company") and states as follows:

1. On October 2, 2024, the parties filed a Unanimous Stipulation and Agreement ("Agreement"), which the Commission approved. Paragraph 5 of the Agreement deferred the Crossroads issue for a potential hearing November 3-7.

2. In its August 21, 2025, *Order Directing Filing*, the Missouri Public Service Commission ("Commission") directed the Parties to file a status report by August 26, 2025, regarding what hearing dates, if any, the parties believe they will need.

3. There is currently no imminent settlement between the parties. Parties are working towards filing Direct testimony as contemplated with the established procedural schedule outlined in the Agreement.

**WHEREFORE**, Evergy respectfully requests that the Commission accept this Status Report and to grant such other and further relief as the Commission considers appropriate.
