**STAFF MOTION FOR ORDER DIRECTING NOTICE**

**COMES NOW** the Staff of the Missouri Public Service Commission, by and through counsel, and for its *Motion Seeking an Order Directing General Notice* states as follows:

1. Pursuant to 4 CSR 240-20.100(7) Kansas City Power & Light ("KCPL") and KCP&L Greater Missouri Operations ("GMO") were required to file annual Renewable Energy Standard ("RES") Compliance Reports and Compliance Plans with the Commission on April 15, 2015.
2. On April 15, 2015, KCPL and GMO applied for and were granted an extension of the filing deadline until April 22, 2015.

3. On April 22, 2015, KCPL and GMO filed their respective annual RES Compliance Reports and RES Compliance Plans with the Commission.

4. Pursuant to 4 CSR 240-20.100(7)(D) Staff shall file a report of its review with the Commission within forty-five (45) days of the filing of the compliance reports. Staff intends to comply by submitting its report to the Commission on or before June 5, 2015.

5. Pursuant to 4 CSR 240-20.100(7)(C), the Commission shall issue a general notice upon filing of RES compliance reports and RES compliance plan. Such general notice has not been made regarding the submission of KCPL and GMO RES compliance reports and plans.

**WHEREFORE**, the Staff respectfully requests the Commission issue a general notice on these matters.
