ORDER CANCELING CERTIFICATE OF SERVICE AUTHORITY

Issue Date: December 30, 2020

Effective Date: January 29, 2021

On December 17, 2021, the Staff of the Missouri Public Service Commission (Staff) filed a motion requesting that the Commission cancel the certificate of intrastate interexchange service authority of Legacy Long Distance International, Inc. (Company) in the State of Missouri. The Commission previously granted the Company a certificate to provide intrastate interexchange service in Case No. TA-2000-342.¹ The Company does not have an applicable tariff. The Staff's motion states that the Company wishes to voluntarily relinquish its authority and cancel any applicable tariffs.

On December 18, 2020, the Commission issued its order that anyone wishing to respond to Staff's Motion or request a hearing do so by filing a pleading no later than December 29, 2020. There were no such filings. The Commission need not hold a hearing if, after proper notice and opportunity to intervene, no party requests such a hearing.² Therefore, the Commission may cancel the certificate based on Staff's motion.

1. The certificate of service authority issued to Legacy Long Distance International, Inc. to provide intrastate interexchange service in the State of Missouri is canceled.
2. This order shall be effective January 29, 2021.
3. This file shall close January 30, 2021.
