On December 15, 2020, the Staff of the Commission filed a recommendation and memorandum regarding its review of The Empire District Gas Company's 2018-2019 Actual Cost Adjustment (ACA). Staff's recommendation includes adjustments that were previously ordered by the Commission in File No. GR-2019-0124 for the 2017-2018 ACA period and included by Empire in File No. GR-2021-0121 for the 2019-2020 ACA period. Staff also made certain recommendations regarding reliability analysis, gas supply planning, and hedging.

The Commission will direct that any responses to Staff's recommendation be filed as set out below.

1. Any responses to the staff recommendation shall be filed no later than January 8, 2021.
