## ORDER APPROVING TARIFF AND ORDER GRANTING MOTION FOR EXPEDITED TREATMENT

Issue Date: August 28, 2025

Effective Date: September 12, 2025

On January 17, 2025, Evergy Metro, Inc., d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc., d/b/a Evergy Missouri West (the Companies) filed a request for a variance of Various Chapter 13 Regulations. The Commission issued an Order Approving Stipulation and Agreement on August 13, 2025 with an effective date of September 12, 2025.

To comply with the Commission's August 13, 2025 order, the Companies filed Tariff Tracking Nos. JE-2026-0014, JE-2026-0015, JE-2025-0016, and JE-2026-0017 on August 20, 2025. The tariffs bear effective dates of September 19, 2025. However, the Companies filed a Motion for Expedited Treatment in which they asked for approval of the tariffs by August 28, 2025. The Companies represent that Staff does not object. Evergy states that good cause exists to approve the tariff on an expedited basis. The Company states that there will be no negative effect on the Company's customers or the general public if the Commission issues an order that allows the Tariffs to go into effect and the Hot and Cold Weather Rule tariffs can be effective.

The Commission allowed parties until August 27, 2025 to object to Evergy's request.  
No party objected.

Because no party objects the Commission will approve the submitted tariff on an expedited basis. The Commission will grant the Motion for Expedited Treatment and approve the tariffs.

**THE COMMISSION ORDERS THAT:**

1. The following tariffs filed by Evergy (Companies), on August 20, 2025 as and assigned Tracking Nos. JE-2026-0014, JE-2026-0015, JE-2026-0016, JE-2026-0017, are approved to become effective on September 12, 2025.
2. The motion for expedited treatment is granted.
3. This order shall become effective on September 12, 2025.
4. This case shall be closed on September 13, 2025.
