## ORDER ESTABLISHING TIME TO RESPOND TO MOTION

Issue Date: January 4, 2021 Effective Date: January 4, 2021

On December 30, 2020, the Staff of the Missouri Public Service Commission (Staff) filed a motion requesting that the Commission cancel the certificate of service authority to provide basic local, local exchange, exchange access and interexchange services of Logix Communications, LP d/b/a Logix Communications (Company). On September 24, 2002, the Commission granted the certificate of service authority at issue in File No. LA-2003-0027. The Staff's motion states that the Company wishes to voluntarily relinquish its authority. The Company has two applicable tariffs that it also requested be cancelled, YL-2006-0871 and YL-2006-0872.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.<sup>1</sup> Therefore, if no request for a hearing or objection to Staff's motion is received, the Commission may cancel the certificate based on Staff's motion.

The Commission finds that proper persons shall be allowed ten days from the issuance of this order to file a motion for hearing.
