## ORDER DIRECTING NOTICE, SETTING DEADLINES FOR FILING RESPONSE OR REQUESTING A HEARING

On June 13, 2016, the Commission's Staff filed its *Report of First MEEIA Prudence Audit* of Kansas City Power & Light Company (KCP&L). Staff reviewed the prudency of costs incurred by KCP&L as part of its demand-side programs and investment mechanisms, originally approved by the Commission in File No. EO-2014-0095. In the report, Staff identifies an imprudent expense by KCP&L during the review period and recommends a disallowance of \$6,000 plus interest for costs improperly billed to customers.

The Commission will direct notice of Staff's report be provided to the parties in File No. EO-2014-0095. Commission rule 4 CSR 240-20.093(10) establishes a ten-day deadline from the filing of Staff's report for the filing of a request for a hearing. Therefore, a request for a hearing on Staff's *Report of First MEEIA Prudence Audit* may be filed no later than Thursday, June 23, 2016. The Commission will set a deadline for entities wishing to intervene or to file a response to Staff's report.

## THE COMMISSION ORDERS THAT:

- 1. The Commission's Data Center shall serve a copy of this order upon all parties to File No. EO-2014-0095.
  - 2. Applications to intervene shall be filed no later than June 23, 2016.
- 3. A response to Staff's *Report of First MEEIA Prudent Audit* may be filed no later than June 23, 2016.
  - 4. Any request for a hearing shall be filed no later than June 23, 2016.
  - 5. This order shall be effective when issued.
