ORDER RECOGNIZING NAME CHANGE

Issue Date: January 7, 2021

Effective Date: February 6, 2021

Northeast Missouri Rural Telephone Company submitted a letter on December 29, 2020, advising that it has changed its name to Northeast Missouri Rural Telephone Company d/b/a NEMR Telecom. The company also filed an updated tariff to reflect the new name. That tariff carries an effective date of January 8, 2021. On January 6, 2021, the Commission's Staff filed a recommendation indicating the company has complied with all statutory and regulatory requirements for changing its name. Staff recommends the Commission recognize the name change and allow the updated tariff to take effect by operation of law. The Commission will do so.

THE COMMISSION ORDERS THAT:

1. The Commission recognizes Northeast Missouri Rural Telephone Company's name change to Northeast Missouri Rural Telephone Company d/b/a NEMR Telecom.
2. The revised tariff filed by Northeast Missouri Rural Telephone Company d/b/a NEMR Telecom (Tariff No. YX-2021-0135) will be allowed to take effect on January 8, 2021.
3. This order shall be effective on February 6, 2021.

4. This file shall be closed on February 7, 2021.
