**ORDER ESTABLISHING TIME TO RESPOND TO STAFF'S REPORT
AND COMMENTS OF UNITED FOR MISSOURI AND RENEW MISSOURI**

On April 15, 2016, Kansas City Power & Light Company (KCP&L) filed its 2016-2018 Renewable Energy Standard Compliance Plan, as required by Commission Rule 4 CSR 240-20.100(8). That regulation requires Staff to file a report about the plan, and offers other interested persons or entities an opportunity to file comments. Staff filed its report on May 26, finding no deficiencies in KCP&L's plan. United For Missouri filed comments on May 28. In its comments, United For Missouri asks the Commission to direct KCP&L to "provide a reasoned analysis why the compliance plan is the least cost, prudent methodology to achieve compliance with the RES as required in its rule". Renew Missouri filed comments on June 1.¹ In its comments, Renew Missouri challenges the method by which KCP&L calculates the one percent Retail Rate Impact (RRI).

Commission Rule 4 CSR 240-20.100(8)(F) allows the Commission to direct KCP&L to provide additional information or to address any concerns or deficiencies

identified by Staff or any other commenter. Before deciding whether any additional information is required or whether any concerns or deficiencies need to be addressed, the Commission will establish a time for the filing of responses to Staff's report and United for Missouri's comments.

THE COMMISSION ORDERS THAT:

1. Any person or entity wishing to respond to Staff's Report on Kansas City Power & Light Company's 2016-2018 Renewable Energy Standard Compliance Plan, or to the Comments of United for Missouri, Inc. or Renew Missouri, shall do so no later than June 13, 2016.
2. This order shall be effective when issued.
