**COMES NOW** Confluence Rivers Utility Operating Company, Inc., (“Confluence Rivers”) and for its *Notice of Closing* states as follows to the Missouri Public Service Commission ("Commission"):

1. On January 2, 2025 (effective February 1, 2025), the Commission issued its Order Approving Acquisition of Assets and Granting a Certificate of Convenience and Necessity (“Order”) in this case. The Order approves the transfer of and grants a Certificate of Convenience and Necessity for Confluence Rivers to own and operate, the sewer assets of United Fiber.

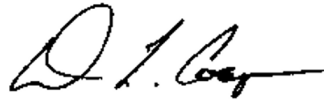
2. Among other things, the Order required Confluence Rivers to notify the Commission of closing on the assets in this case or file a status report if closing has not yet occurred.
