The motion represents that Empire and Staff do not object to extending the due date for surrebuttal testimony.

The Commission will grant Public Counsel's motion.

1. Public Counsel's Motion for a One-Day Extension to File Surrebuttal Testimony is granted.

2. The procedural schedule is modified to allow all parties to file surrebuttal testimony no later than July 28, 2017.
