## ORDER DIRECTING STAFF RECOMMENDATION AND SETTING TIME FOR RESPONSES

Issue Date: August 29, 2025 Effective Date: August 29, 2025

On August 29, 2025, Liberty Utilities d/b/a Liberty filed proposed revisions to its Weather Normalization Adjustment Rider (WNAR) tariff sheet which were assigned Tracking No. JG-2026-0025. Liberty projects that the changes to the WNAR tariff sheets will decrease the average monthly bill of the typical residential customer in its Northeast district by \$0.42, West district by \$0.16, and Southeast district by \$0.25. The tariff sheet bears an October 1, 2025 effective date.

The Staff of the Commission (Staff) will be directed to file a recommendation. The Commission will also establish a deadline for any other entity to file a response to the proposed tariff changes or to the Staff recommendation.

#### THE COMMISSION ORDERS THAT:

- 1. No later than September 11, 2025, Staff shall file a recommendation regarding Tracking No. JG-2026-0025.
- 2. Any other entity wishing to respond to the tariff changes or Staff's recommendation shall do so no later than September 17, 2025.
  - 3. This order is effective when issued.
