**ORDER DIRECTING COMPLAINANT TO SHOW CAUSE  
WHY COMPLAINT SHOULD NOT BE DISMISSED**

On August 21, 2025, the Commission issued an order setting a procedural conference in this matter for September 2, 2025, at 10:00 a.m., to be conducted via WebEx telephone and video conference. Counsel for Spire Missouri Inc. d/b/a Spire, counsel for the Staff of the Commission, and counsel for the Office of the Public Counsel appeared for the conference at the scheduled date and time. Complainant Bobby J. Armour did not appear.

Commission Rule 20 CSR 4240-2.090(5) states, "Failure to appear at a prehearing conference without previously having secured a continuance shall constitute grounds for dismissal of the party or the party's complaint . . . unless good cause for the failure to appear is shown."

The Commission will not dismiss the complaint without giving Mr. Armour an opportunity to explain why he did not attend the procedural conference. Thus, the Commission will order Mr. Armour to file a pleading showing cause as to why his complaint should not be dismissed.

**THE COMMISSION ORDERS THAT:**

1. No later than September 16, 2025, Complainant Bobby J. Armour shall file a pleading showing cause why his complaint against Spire should not be dismissed for failure to appear.
2. This order is effective when issued.
