ORDER DIRECTING A FURTHER STATUS REPORT

A requested status report was filed by Evergy Metro, Inc. and Evergy Missouri West, Inc. (together “Evergy”) on January 8, 2021. It indicated that settlement discussions are actively continuing, and that an agreement among the parties appears possible with additional time. Evergy asks to be allowed until February 8, 2021, to file either an agreement or a further status report.¹

Evergy stated that it contacted the other parties and none objected to this request. Based on the representation of counsel, the Commission will consider the request for additional time unopposed. The Commission finds that the unopposed request for additional time is reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. The parties shall file an agreement or a further status report no later than February 8, 2021.
2. This order shall be effective when issued.

¹ The Commission is aware that later on January 8, 2021, a Unanimous Partial Stipulation and Agreement was filed. The Commission reads the later filing in conjunction with the extension request made almost exactly one hour prior and understands that the parties are requesting an extension of time to negotiate the issues that are not addressed in the filed Unanimous Partial Stipulation and Agreement.
