ORDER ON MOTION FOR EXTENSION

On December 11, 2020, Ameren Transmission Company of Illinois (ATXI) applied for an order declining jurisdiction or, alternatively, requesting a certificate of convenience and necessity to operate and maintain interconnection facilities in Schuyler County, Missouri.

On December 15, 2020, the Commission directed the Staff of the Commission to file either a recommendation regarding ATXI's application or a status report advising when it expects to file a recommendation.

On January 11, 2021, Staff filed its *Motion for Extension* and advised Staff continues to review information provided by ATXI. Staff states it expects to file its recommendation no later than January 18, 2021.

The Commission will grant the request for extension and will extend the time period to account for the holiday on January 18, 2021.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation regarding ATXI's application no later than January 19, 2021.

2. This order shall be effective when issued.
