MOTION TO CONSOLIDATE

- 1. On September 3, 2025, MAWC filed a *Petition to Establish a Water and Sewer Infrastructure Rate Adjustment and Motion for Approval of Customer Notice* (*Petition*) with the Commission. MAWC seeks to establish a water WSIRA and sewer WSIRA to provide for the recovery of costs for infrastructure system projects eligible for WSIRA recognition. This *Petition* was submitted in Files Nos. WR-2025-0345 and SR-2025-0346.
- 2. MAWC is the applicant in both above-captioned cases. The files reference the same subject matter, will involve similar parties and will contain common questions of law and fact. Consolidation would promote administrative efficiency for filings and any discovery.
- 3. Pursuant to Commission Rule 20 CSR 4240-2.110(3), the Commission may issue orders concerning pending cases to avoid unnecessary costs or delays if the actions involve related questions of law or fact. MAWC requests the Commission consolidate the above-captioned matters, designating WR-2025-0345 as the lead case.

granting such further and other relief as is just and proper in the circumstances.
