NOTICE THAT PLEADING WAS REJECTED AS DEFICIENT

Issue Date: September 3, 2025

On September 2, 2025, Complainant, Brett Felber, filed a document captioned "*Formal Complaint and Motion for Default Summary Judgment*" (Motion). The Motion is not compliant with Commission Rule 20 CSR 4240-2.117, and does not explain why Complainant is entitled to relief as a matter of law.

Instead the Motion attempts to file a new complaint within this complaint. Any new complaints would need to be filed as such and not within this case.

The Motion also alleges violations of Section 407 RSMo, over which the Commission has no jurisdiction.

Further, the Motion attempts to reassert evidence and argument from a prior complaint case, Case No. EC-2023-0395. That case is final. Complainant failed to appeal that case when given the opportunity. Thus, Complainant is barred from relitigating issues and evidence from that case, which would constitute an impermissible collateral attack on a Commission order.

Finally, Complainant requests the Commission impose a restraining order, enter judgment in Complainant's favor, and order restitution. The Commission cannot grant restitution or a restraining order, and for reason's enumerated above, Complainant's Motion is deficient.

The Commission rejected Complainant's Motion and attachments as deficient.
