**NOTICE THAT PLEADING WAS REJECTED AS DEFICIENT**

Issue Date: September 3, 2025

On September 3, 2025, Complainant, Brett Felber, filed a document captioned "*Memorandum calling for investigation*". This pleading is deficient and was rejected by the Commission for alleging violations of federal law over which the Commission has no jurisdiction.

The pleading again attempts to reassert evidence and argument from a prior complaint case, Case No. EC-2023-0395. Complainant has previously been informed that he failed to appeal that case and the Commission's order is final and unappealable. Complainant's reassertion of evidence from that case is an impermissible collateral attack on a Commission order.

The Commission rejected Complainant's pleading as deficient.
