STATUS REPORT

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”),
by and through counsel, and in response to the Commission’s July 31, 2025,
Order Extending Time for Report states:

1. On August 28, 2024, Staff filed a Motion to Establish a Case requesting the Commission open a file for investigation of a natural gas pipeline incident in Independence, Missouri. The Motion described an incident that occurred on August 26, 2024, in Independence, Missouri, an area served by Spire Missouri Inc. d/b/a Spire (“Spire”). A third-party excavator installing fiber optic cable by directional drilling hit a sewer lateral to the house located at 426 E. Fair Street, and Spire’s nearby 4-inch natural gas main. The natural gas migrated into the house and ignited, resulting in an explosion and house fire.

2. Staff performed an initial visit to the incident site location on August 27, 2024, to discuss the work being performed and events leading up to the incident.

3. On September 5, 2024, the Commission granted Staff’s Motion and ordered Staff to file a report regarding the incident or a report on the status of its investigation no later than December 13, 2024.

4. On December 12, 2024, Staff filed a Status Report, stating that it was continuing to conduct discovery in this matter.

5. On December 13, 2024, the Commission ordered that Staff's investigative report, or a report on the status of Staff's investigation, shall be filed no later than February 14, 2025.

6. On February 13, 2025, Staff filed a Status Report, stating that it was continuing to conduct discovery in this matter and there were numerous outstanding data requests associated with this matter.

7. On February 13, 2025, the Commission ordered Staff to file an investigation report or a status report no later than April 30, 2025.

8. On April 23, 2025, Staff filed a Status Report, stating that it was continuing to conduct discovery in this matter and there were numerous outstanding data requests associated with this matter.

9. On April 25, 2025, the Commission ordered Staff to file an investigation report or a status report no later than July 31, 2025.

10. On July 30, 2025, Staff filed a Status Report, stating that it was continuing to conduct discovery in this matter and there were numerous outstanding data requests associated with this matter.

11. On July 31, 2025, the Commission granted Staff's request for an extension to September 12, 2025.

12. Since the previous Staff Status Report, Staff has: provided a draft copy of the facts section of the report to Spire for its review of confidential information and verification of factual accuracy; received and reviewed Spire's feedback on the facts section of the report; and have submitted five follow-up data requests to Spire, with the latest due date being September 10, 2025.

13. Staff will use this time to review Spire's responses to Staff data requests, revise the draft report based on responses from the data requests, submit its revised report to internal review, and request, receive and review Spire's identification of confidential information and feedback on the report's facts section, if needed.

14. Staff requests a due date of no later than October 3, 2025, to file a report regarding its investigation, or a report on the progress of Staff's investigation.

WHEREFORE, for the above-stated reasons, Staff respectfully requests the Commission order Staff to file a report regarding its investigation, or a report on the status of Staff's investigation, no later than October 3, 2025, and to grant such other and further relief as the Commission considers just and reasonable under the circumstances
