AFFECTED RULE: 4 CSR 240-3.162

FORM OF ACTION: Petitioners Office of Public Counsel and Missouri Industrial Energy Consumers filed writs of review of the Public Service Commission's Final Order of Rulemaking pursuant to Section 386.510, RSMo, seeking to have the rule invalidated by the circuit court. The Public Service Commission acknowledged the existence of procedural flaws in the underlying rulemaking proceeding and the parties jointly moved for a reversal of the Final Order of Rulemaking.
