On September 12, 2025,<sup>1</sup> the Commission held a discovery conference in this matter. The discovery conference discussed eight Data Requests (DRs). The DRs at issue are as follows:

- a. DR 0459.0, regarding late fees;
- b. DR 0481.0, regarding meter data management system;
- c. DR 0482.0, regarding billing exceptions;
- d. DR 0483.0, regarding billing determinants missing intervals;
- e. DR 0484.0, regarding estimated bills;
- f. DR 0499.0, regarding cyber-security actual and budgeted costs;
- g. DR 0479.0 responded, but with requested follow-up; and
- h. DR 0493.0 responded, but with requested follow-up.

The attendees discussed the status of pending due dates, including that surrebuttal and true-up direct testimony are currently due September 15, true-up rebuttal is due September 22, and that the upcoming evidentiary hearing that begins October 6.

Pursuant to that discussion, the Commission issued two orders at the Discovery Conference which are restated here for the convenience of the parties:

- Empire Electric shall file its responses to the eight DRs (referenced above) no later than noon on Monday, September 15;
- The time for **all** parties to file surrebuttal and true-up direct is extended to no later than noon on Wednesday, September 17.
