The Commission issued its *Order Approving Tariff and Order Granting Motion for Expedited Treatment* in this matter on August 28, 2025, becoming effective on September 12, 2025. That order approved compliance tariffs, Tracking Nos. JE-2026-0014, JE-2026-0015, JE-2026-0016, JE-2026-0017, to become effective on September 12, 2025.

The Commission issues this order to correct the error of the effective date of two of those tariffs. Tracking Nos.
