NOTICE THAT PLEADINGS WERE REJECTED AS DEFICIENT

Issue Date: September 15, 2025

From September 9, 2025, through September 15, 2025, Complainant, Brett Felber, submitted documents for filing in the Commission's Electronic Information Filing System (EFIS). Several of these pleadings are being rejected as deficient.

The September 13, 2025, *Tegridy Memorandum*¹ is deficient and was rejected by the Commission because it was filed by an alleged third-party LLC, that had not applied to intervene. An LLC would also require an attorney to represent it before the Commission.

The August 14, 2025, email between Tegridy Midwest Dairy & Produce Farms LLC and an Ameren Missouri Attorney titled *Protective Order* is rejected because it again involves an entity not granted intervention in this complaint.

The document titled *How to Catch a Commission and Utility Company* and its accompanying PNG graphic are rejected because neither is a proper pleading.
