## ORDER CHANGING DATES OF EVIDENTIARY HEARING

Issue Date: September 16, 2025

Effective Date: September 16, 2025

The two-week evidentiary hearing in this matter is set for October 6, 2025,<sup>1</sup> through October 17. The Commission's order setting the procedural schedule in this matter indicated that a scheduling conflict may cause the evidentiary hearing to adjourn for part or all of October 7.<sup>2</sup> October 20 is reserved for an overflow day if necessary.

The PowerMO Summit, organized by the Commission, has been scheduled for October 7. The PowerMO Summit agenda indicates activities occurring from 8:00 a.m. to at least 4:15 p.m., and includes the participation of all Commissioners.

For that reason, the Commission will change the dates of the evidentiary hearing in this matter to October 6, and October 8-20.

### THE COMMISSION ORDERS THAT:

1. The evidentiary hearing currently set October 6 through October 17 is changed to October 6, and October 8-20 (note October 13 is a state holiday).
2. This order shall be effective when issued.
