STAFF RECOMMENDATION FOR APPROVAL OF TARIFF REVISION

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), by and through counsel, and respectfully states as follows:

1. On August 27, 2024, Confluence Rivers Utility Operating Company, Inc. (“Confluence”) and Missouri-American Water Company (“MAWC”) jointly filed an application with the Missouri Public Service Commission (“Commission”) for Confluence to acquire nineteen (19) wastewater systems owned by MAWC.
2. On December 30, 2024, Staff recommended that the Commission approve the abovementioned acquisition.
3. Following litigation, the Commission approved the acquisition on August 20, 2025, in its *Report and Order*.
4. On September 8, 2025, in compliance with the Commission’s *Report and Order*, Confluence filed a tariff revision (Tracking No. JS-2026-0031).
5. On September 10, 2025, the Commission ordered Staff to “file a recommendation about Confluence Rivers’ tariff revision no later than September 17, 2025”.

6. Staff conducted a full review of the tariff revisions and recommends the Commission issue an order approving the following tariff sheets (each bearing an issue date of September 8, 2025, and a proposed effective date of October 8, 2025):


