ORDER DENYING APPLICATION FOR REHEARING

On August 20, 2025, the Missouri Public Service Commission issued its *Report and Order* authorizing Confluence Rivers Utility Operating Company, Inc., to acquire certain sewer assets from Missouri-American Water Company. That order became effective August 30, 2025. On August 29, 2025, the Office of the Public Counsel filed a timely application for rehearing.

Section 386.500.1, RSMo 2016, states that the Commission shall grant an application for rehearing if “in its judgment sufficient reason therefor be made to appear.” In the judgment of the Commission, the Office of the Public Counsel’s application for rehearing does not demonstrate sufficient reason to rehear the matter. The Commission will deny the application for rehearing.

THE COMMISSION ORDERS THAT:

1. The Office of the Public Counsel’s application for rehearing is denied.

2. This order shall be effective when issued.
