INTRODUCTION / PURPOSE OF EXHIBIT

Pursuant to the procedural rules governing discovery and filings before the Missouri Public Service Commission, Complainant Brett Felber hereby files this Exhibit to notify the Commission, Respondent Ameren Missouri, and Commission Staff that a document supplied by Ameren Missouri in this proceeding is, on its face and based on a forensic examination, a counterfeit and altered document. This Exhibit summarizes the forensic findings, identifies the relevant indicators of manipulation, and attaches (as Exhibit A) the full Forensic Analysis Report produced by Data Recovery Service Consultants LLC.

SUMMARY OF FACTUAL ASSERTIONS

- 1. Ameren Missouri supplied a document to the Complainant and/or to the Commission in this matter that has been represented by Respondent as a treasury/bank statement or similar financial record.
- 2. The document, however, contains multiple artifacts and metadata inconsistent with an authentic bank/treasury record and is therefore suspected to be counterfeit, forged, or otherwise manipulated.
- 3. The attached Forensic Analysis Report (Exhibit A) was prepared and supplied by Data Recovery Service Consultants LLC and documents the testing, methodology, and results that lead to the conclusion that the supplied document is not an authentic bank/treasury statement.
- 4. The Forensic Analysis Report indicates the document was created on an iOS platform and was produced or exported as a PDF using a PDF editor/generator consistent with an iPad or iPhone environment specifically, consistent with the iOS device(s) in the possession of or attributed to Aubrey Krcmar.
- 5. Based on the foregoing, Complainant alleges Respondent has withheld authentic treasury records and instead supplied or allowed the filing of a document that is counterfeit or altered.

KEY FORENSIC FINDINGS (SUMMARY)

Indicators include:

- File creation metadata consistent with an iOS PDF editor rather than a banking system export;
- Visible editing artifacts (layering, inconsistent fonts, font metrics) indicating assembly in a PDF editor;
- Metadata timestamps inconsistent with institutional banking records:
- Absence of bank-system security features usually present in authentic statements;
- Embedded object traces consistent with manual composition on a mobile device.

The attached Exhibit A contains the full technical details, methodology, and supporting data.

Complainant respectfully requests the Commission to:

- 1. Accept this Exhibit into the record;

- 4. Grant such other relief as the Commission deems proper.
