Study of Economic Impact to Prairie Hollow Consumers from Electric Service Provider

The following summarizes key inputs and results of the study completed to evaluate economic impact to residential consumers in the Prairie Hollow subdivision based on their electric service. Electric service providers reviewed were Central Missouri Electric Cooperative (CMEC) and Evergy. A random sample of residential sites in a nearby subdivision served by CMEC was taken to generate reasonable monthly kWh & kW determinants for the new Prairie Hollow Subdivision. 61,320 hourly intervals (8,760 per site) were analyzed for proper application to time-of-use rates. Present default rates, as of September 2025, were input for both CMEC and Evergy. Evergy riders and adjustments, which regularly fluctuate, were estimated based on 60 month weighted average.

Results show that there is no <u>significant</u> positive or negative impact to consumers from either electric service. Note that there is a slightly better economic impact to the average consumer with CMEC service compared to Evergy after application of the future Capital Credit payment. For transparency, this payment is discounted to a present value based on CMEC's present Capital Credit retirement cycle of 14 years and most recent board approved discount rate.
