## NOTICE OF DEFICIENCY

Issue Date: September 22, 2025

On September 15, 2025, Brett Felber's *Motion to Disqualify or Reassign Administrative Law Judge/Commissioner* was filed in this case. Felber's motion requests that the "currently assigned Administrative Law Judge/Commissioner" be disqualified or reassigned from this case.

Commission Rule 20 CSR 4240-2.120 sets out the procedure for motion to disqualify the presiding officer (Regulatory Law Judge) in Commission cases. That rule requires the motion be accompanied by "affidavits setting forth the grounds alleged for disqualification." Felber's motion is deficient because no such affidavit was attached. Felber is hereby notified that no action will be taken on the motion until the deficiency is cured. Further, if the deficiency is not cured by October 13, 2025, the motion will be dismissed.
