ORDER APPROVING TARIFF REVISION

Issue Date: September 22, 2025

Effective Date: October 8, 2025

On September 8, 2025, Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed a tariff revision, Tracking No. JS-2026-0031, to comply with the Commission's August 20, 2025, *Report and Order*, authorizing it to purchase 19 small sewer systems from Missouri-American Water Company. That tariff revision bears an effective date of October 8, 2025. The Commission ordered its Staff (Staff) to file a recommendation about the tariff revision and set a deadline for other tariff responses. Staff filed a recommendation to approve the tariff revision. No other responses were received.

The Commission has reviewed the tariff revision and Staff's recommendation and finds that the tariff revision should be approved. The Commission will approve Confluence Rivers' tariff revision to become effective on October 8, 2025. Accordingly, the Commission finds it reasonable to make this order effective in less than 30 days so that the order will be effective concurrently with the compliance tariff revision.

THE COMMISSION ORDERS THAT:

1. Confluence Rivers' tariff revision, assigned Tracking No. JS-2026-0031, is approved to become effective on October 8, 2025.
2. This order shall become effective on October 8, 2025.
