**EVERGY MISSOURI WEST  
APPLICATION TO INTERVENE**

**COMES NOW**, Evergy Missouri West, Inc. d/b/a Evergy Missouri West (“EMW” or the “Company”) and, pursuant to 20 CSR 4240-2.075(10), submit this *Application to Intervene* (“Application”) in the above-captioned docket. In support of its Application, EMW states as follows:

**APPLICATION TO INTERVENE**

1.       EMW is a Delaware corporation with its principal office and place of business at 1200 Main Street, Kansas City, Missouri 64105. It is engaged in the generation, transmission, distribution, and sale of electricity in western Missouri, including the suburban Kansas City metropolitan area, St. Joseph, Warrensburg, Sedalia, and surrounding counties. Evergy Missouri West is an “electrical corporation” and a “public utility” subject to the jurisdiction, supervision, and control of the Commission under Chapters 386 and 393.

2.       A certificate of authority for EMW to do business in Missouri as a foreign corporation was filed with the Commission in No. EN-2020-0064 and is incorporated by reference pursuant to 20 CSR 4240-2.060(1)(G).

4. On September 19, 2025, Central Missouri Electric Cooperative, Inc. a Missouri Rural Electric Cooperative (“Cooperative”) opened this docket by filing its Application seeking an order approving designated service boundaries (“Application”).

5. On September 19, 2025, the Missouri Public Service Commission (“Commission”) issued its *Order and Notice* (“Order”) in this docket, setting an intervention deadline of October 3, 2025.

6. EMW’s certificated service territory includes the city of Sedalia and EMW has a franchise agreement with the city of Sedalia. EMW currently serves approximately 14,000 customers in Sedalia including several large customers such as Nucor.

7. The Company’s intervention will serve the public interest as EMW will provide additional perspective to the Commission regarding the issues involved.

8. The Company’s interest with regard to the Application is different than that of the general public, as illustrated by the fact that EMW is a Missouri investor-owned electric utility and is authorized to serve the property which the cooperative seeks to serve. This interest may be impacted by the Commission’s decision in this case.

9. EMW requests an order approving its intervention as soon as possible as it cannot access the confidential materials filed by the cooperative until it is a party in the case.

10. As shown above, good cause exists to permit the Company's intervention. The Company intervention application was made as soon as practicable and is only three days after the Commission issued its Order.

**WHEREFORE**, the Company respectfully requests that the Commission issue an order authorizing it to intervene in the above-captioned docket.
