ORDER CANCELLING CERTIFICATE OF SERVICE AUTHORITY

Issue Date: January 15, 2021

Effective Date: February 14, 2021

On December 30, 2020, the Staff of the Missouri Public Service Commission (Staff) filed a motion requesting that the Commission cancel the certificate of service authority to provide basic local, local exchange, exchange access and interexchange services of Logix Communications, LP d/b/a Logix Communications (Company). The Commission previously granted the Company the certificate of service authority in File No. LA-2003-0027. The Company has two applicable tariffs that it also requested be cancelled, YL-2006-0871 and YL-2006-0872. The Staff's motion states that the Company wishes to voluntarily relinquish its authority and cancel any applicable tariffs.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo (2016), which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

On January 4, 2021, the Commission issued its order that anyone wishing to respond to Staff's Motion or request a hearing do so by filing a pleading no later than January 14, 2021. There were no such filings. The Commission need not hold a hearing

if, after proper notice and opportunity to intervene, no party requests such a hearing.¹
Therefore, the Commission may cancel the certificate based on Staff's motion.

Based on Staff's motion, the Commission finds that the certificate of service authority granted to Logix Communications, LP d/b/a Logix Communications shall be cancelled.

THE COMMISSION ORDERS THAT:

1. The certificate of service authority issued in File No. LA-2003-0027 to Logix Communications, LP d/b/a Logix Communications to provide basic local, local exchange, exchange access and interexchange services in the State of Missouri is cancelled.
2. Logix Communications, LP d/b/a Logix Communications' Tariff Nos. YL-2006-0871 and YL-2006-0872 are cancelled.
3. This order shall be effective February 14, 2021.
4. This file shall close February 15, 2021.
