**REQUEST TO APPEAR REMOTELY**

COMES NOW Data Center Coalition (“DCC”) and requests permission for the undersigned counsel Nikhil Vijaykar, co-counsel Alissa Greenwald, and witnesses Kevin Higgins and Shana Ramirez to appear remotely at the Evidentiary Hearing in this matter. In support of this request, DCC states as follows:

1. This matter is currently set for an evidentiary hearing on September 29<sup>th</sup> through October 3<sup>rd</sup>.
2. DCC intends to present two witnesses at the hearing, Kevin Higgins and Shana Ramirez.
3. Mr. Higgins and Ms. Ramirez reside outside of the State of Missouri and therefore, to avoid the time and expense associated with travel, would like to present testimony remotely.
4. Mr. Vijaykar and Ms. Greenwald also reside outside of the State of Missouri and therefore, to avoid the time and expense associated with travel, would like to appear remotely. Moreover, remote participation is necessary for Mr. Vijaykar to avoid conflicts with additional hearings, as well as to accommodate travel following Ms. Greenwald’s wedding.
5. In the alternative to complete remote participation by counsel, DCC requests that the Commission permit both Mr. Vijaykar and Ms. Greenwald to appear remotely on

Monday, September 29<sup>th</sup>. Subsequently, Ms. Greenwald will appear in person, while Mr. Vijaykar will continue to appear remotely.

6. No parties have indicated that they object to this request.<sup>1</sup>

WHEREFORE, DCC respectfully requests the Public Service Commission grant this Request to Appear Remotely and for such other relief as is deemed proper under the circumstances.
