ORDER APPROVING FUEL ADJUSTMENT TRUE-UP AND APPROVING TARIFF TO CHANGE FUEL ADJUSTMENT RATES

Issue Date: May 19, 2021 Effective Date: June 1, 2021

In File No. EO-2021-0329, Union Electric Company d/b/a Ameren Missouri submitted its true-up filing related to the company's fuel adjustment clause, as provided by Commission Rule 20 CSR 4240-20.090(9). The true-up filing concerns billing months June 2020 through January 2021, which are designated Recovery Period 33. Ameren Missouri's filing indicates during that period it over-recovered \$1,014,918 from customers. Staff on May 3, 2021, recommended the Commission approve Ameren Missouri's true-up filing of \$1,014,918 in over-recovered costs for Recovery Period 33. The true-up amount for Recovery Period 33 is used to calculate the fuel adjustment rates proposed by Ameren Missouri's filing in File No. ER-2021-0328.

On April 1, 2021, Ameren Missouri filed a tariff in File Nos. ER-2021-0328 and EO-2021-0329, proposing to increase the company's fuel adjustment rates, as provided by Commission Rule 20 CSR 4240-20.090(8). Ameren Missouri proposes to increase the

fuel adjustment rates per kilowatt hour (kWh) to \$0.00308 for primary service and \$0.00298 for secondary service, effective June 1, 2021. Ameren Missouri's filing indicates the increased rates reflect changes in actual net energy costs experienced by the company during October 2020 through January 2021, which are designated Accumulation Period 36. The rate adjustment includes the true-up for Recovery Period 33. For a residential customer using 1,000 kWh per month of secondary service, the tariff increases the fuel adjustment charge by about \$2.82 per month, from \$0.26 to \$3.08 per month.

On May 3, 2021, Staff recommended the Commission issue an interim rate adjustment order to approve Ameren Missouri's proposed tariff sheet to be effective on June 1, 2021, subject to true-up and prudence review. The Commission has received no other responses to Ameren Missouri's filings in these cases.

On the basis of Staff's review and recommendation and Ameren Missouri's uncontested filings, the Commission concludes Ameren Missouri's true-up filing and amount in File No. EO-2021-0329 should be approved. In addition, based on Staff's review and recommendation, the Commission finds the proposed tariff, filed on April 1, 2021, complies with Ameren Missouri's tariffs and all applicable statutes and regulations.

To allow the tariff sheet to take effect on June 1, 2021, the Commission will issue its order with an effective date fewer than 30 days from the date of issuance.

THE COMMISSION ORDERS THAT:

Ameren Missouri's true-up filing and true-up amount for Recovery Period 33 is approved.

2. The following tariff sheet, assigned Tariff No. YE-2021-0177, is approved as an interim rate adjustment, subject to true-up and prudence review, and shall be effective on June 1, 2021:
