Beginning at the Southwest Corner of **Section 20, Township 24 North, Range 32 West**; thence North, along the West Line of said **Section 20** to the Northwest Corner thereof, being also the Southwest Corner of **Section 17**; thence North, along the West Line of said Section to the Northwest Corner thereof, being also the Southwest Corner of **Section 8**; thence North, along the West Line of said Section to the Northwest Corner thereof, being also the Southwest Corner of **Fractional Section 5**; thence North, along the West Line of said Fractional Section to the Northwest Corner thereof, being also on the **Dividing Line** between **Townships 24 North and 25 North**; thence West, along said Dividing Line to the Southwest Corner of **Section 34, Township 25 North, Range 32 West**; thence North, along the West Line of said **Section 34** to the Northwest Corner thereof, being also the Southwest Corner of **Section 27**; thence North, along the West Line of said **Section 27** to the Northwest Corner thereof, being also the Southeast Corner of **Section 21**; thence West, along the South Line of said **Section 21** to the Southwest Corner thereof; thence North, along the West Line of said **Section 21** to the Northwest Corner thereof, being also the Southwest Corner of **Section 16**; thence North, along the West Line of said **Section 16** to the Northwest Corner thereof; thence East, along the North Line of said **Section 16** to the Northeast Corner thereof, being also the Northwest Corner of **Section 15**; thence East, along the North Line of said **Section 15** to the Northeast Corner thereof, being also the Northwest Corner of **Section 14**; thence East, along the North Line of said **Section 14** to the Northeast Corner thereof, being also Southwest Corner of **Section 12**; thence North, along the West Line of said **Section 12** to the Northeast Corner thereof; thence East, along the North Line of said Section 12 to the Northeast Corner thereof, being also the Northwest Corner of **Section 7, Township 25 North, Range 31 West**; thence East, along the North Line of said **Section 7** to the Northeast Corner thereof; thence South, along the East Line of said **Section 7** to the Southeast Corner thereof, being also the Northeast Corner of **Section 18**; thence South, along the East Line of said **Section 18** to the Southeast Corner thereof, being also the Northwest Corner of **Section 20**; thence East, along the North Line of said **Section 20** to the Northeast Corner thereof, being also the Northwest Corner of **Section 28**; thence East, along the North Line of said **Section 28** to the Northeast Corner thereof, being also the Northwest Corner of **Section 27**; thence East, along the North Line of said **Section 27** to the Northeast Corner thereof; thence South, along the East Line of said **Section 27** to the

Southeast Corner thereof, being also the Northeast Corner of **Section 34**; thence South, along the East Line of said **Section 34** to the Southeast Corner thereof, being also the Dividing Line between **Township 24 and 25**; thence West, along said **Dividing Line** to the **Northeast Corner of Fractional Section 6, Township 24 North, Range 31 West**; thence South, along the **East Line** of said **Fractional Section 6** to the Northeast Corner of **Section 7**; thence South, along the East Line of said **Section 7** to the Southeast Corner thereof, being also the Northeast Corner of **Section 18**; thence South, along the East Line of **Section 18** to the Southeast Corner thereof; thence West, along the South Line of said **Section 18** to the Southwest Corner thereof, being also the Southeast Corner of **Section 13, Township 24 North, Range 32 West**; thence West, along the South Line of said **Section 13** to the Southwest Corner thereof, being also the Northeast Corner of **Section 23**; thence South, along the **East Line** of said **Section 23** to the Southeast Corner thereof; thence West, along the South Line of said **Section 23** to the Southwest Corner thereof, being also the Southeast Corner of said **Section 22**; thence West, along the South Line of said **Section 22** to the Southwest Corner thereof, being also the Southeast Corner of **Section 21**; thence West, along the South Line of said **Section 21** to the Southwest Corner thereof, being also the Southeast Corner of **Section 20**; thence West, along the South Line of said **Section 20** to the Southwest Corner thereof and the POINT OF BEGINING, containing 1,237,773,190 square feet or 28,415 acres, more or less.
