ORDER DIRECTING STAFF RECOMMENDATION ON COMPLIANCE TARIFF AND SETTING DEADLINE FOR RESPONSES

On September 3, 2025, the Commission issued its *Order Approving Stipulation and Agreement*. On September 24, 2025, Spire filed tariff sheets purporting to comply with the Order. The tariff sheets were assigned Tracking No. JG-2026-0039 and bear an effective date of October 24, 2025.

The Commission will direct its Staff to file a recommendation about the proposed tariff sheets. The Commission will also establish a deadline for any other responses to the proposed tariff sheets.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation about Spire's proposed tariff sheets no later than October 8, 2025.
2. Any other responses to Spire's proposed tariff sheets or Staff's recommendation shall be filed no later than October 10, 2025.
3. This order shall be effective when issued.
