**ORDER APPROVING TARIFF SHEETS IN COMPLIANCE WITH
COMMISSION ORDER**

Issue Date: June 29, 2023

Effective Date: July 9, 2023

On June 28, 2023, the Commission issued its order directing Union Electric Company d/b/a Ameren Missouri to file substitute compliance tariff sheets and delegating authority to the Regulatory Law Judge to approve any Ameren Missouri compliance tariff sheets. That order denied the Office of the Public Counsel's objection to previously filed compliance tariff sheets; delegated authority to the Regulatory Law Judge to approve compliance tariff sheets; directed the filing of substitute compliance tariff sheets calculated for a July 9, 2023 effective date; and set time for the Staff of the Commission (Staff) and other parties to file any responses to Ameren Missouri's substitute compliance tariff sheets.

Ameren Missouri filed 18 substitute compliance tariff sheets on June 28, 2023. The Commission gave parties until 2:00 p.m. on June 29, 2023, to file any comments about the substitute compliance tariff sheets. Staff submitted a recommendation that the Commission approve the compliance tariff sheets filed under Tracking No. YE-2023-0222 on June 19, 2023, and those substituted and further substituted on June 22, 2023, and substituted on June 28, 2023, and the tariff sheets designated Tracking No.

YE-2023-0227 on June 22, 2023, to take effect on July 9, 2023. No other responses were received.

The Commission specifically delegated its authority to approve the tariff and make a determination if good cause exists for the tariff to take effect in less than thirty days to the Regulatory Law Judge assigned to this file, under Section 386.240 RSMo. The Regulatory Law Judge finds that good cause exists for Ameren Missouri's compliance tariff sheets to take effect in less than thirty days because the Commission approved a Stipulation and Agreement in this case that contemplates Ameren Missouri's tariff sheets taking effect July 1, 2023. Ameren Missouri's compliance tariff sheets should be approved expeditiously so that new rates can go into effect as soon as possible. Therefore, Ameren Missouri's compliance tariff sheets submitted under Tracking No. YE-2023-0222 on June 19, 2023, and those substituted and further substituted on June 22, 2023, and substituted on June 28, 2023, and the tariff sheets designated Tracking No. YE-2023-0227 on June 22, 2023, will be approved to become effective with less than thirty days' notice. For those same reasons, the Regulatory Law Judge finds it reasonable to make this order effective in less than thirty days.

THE COMMISSION ORDERS THAT:

1. The compliance tariff sheets submitted under Tracking No. YE-2023-0222 on June 19, 2023, and those substituted and further substituted on June 22, 2023, and substituted on June 28, 2023, and the tariff sheets designated Tracking No. YE-2023-0227 on June 22, 2023, and as enumerated in Staff's June 29, 2023, *Staff Recommendation and Response to Commission Order*, are approved to be effective on and after July 9, 2023.

2. This order shall become effective on July 9, 2023.
