ORDER DIRECTING NOTICE, SETTING INTERVENTION DEADLINE, AND DIRECTING STAFF RECOMMENDATION

On September 24, 2025, Missouri-American Water Company (MAWC) filed applications seeking an order granting an expansion of its existing Certificates of Convenience and Necessity (CCNs). The expansion would authorize MAWC to construct, install, own, operate, maintain, and otherwise control the water and sewer systems in various areas in Missouri, specifically in or around the following locations:

- Maplewood, Monsees Lake Estates, Smithton Service Area (which are located in Pettis County);
- Tri-States, Riverside Estates, Lake Taneycomo Acres Service Area (Taney County);
- Garden City Service Area (Cass County);
- Purcell Service Area (Jasper County);
- Hickory Hills & Temple Terrace Service Area (Moniteau County);
- Emerald Pointe Service Area (Taney County);
- Ozark Mountain, Lakewood Manor Service Area (Barry and Stone Counties);
- City of Arnold & surrounding area (Jefferson County);
- Meramec (Fenton) Service Area (Jefferson County); and,
- Hallsville Service Area (Boone County).

MAWC's application states that it currently serves customers in certain areas outside of, but directly adjacent to, its existing CCNs in certain areas and the proposed expansions are intended to resolve this existing issue. The application also requested a waiver of the 60-day notice requirement of Commission Rule 20 CSR 4240-4.017(D).

The Commission will provide notice of the application to the general public and interested parties and set a deadline for intervention requests. The Commission will also direct its Staff to file its Recommendation regarding the application.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall provide a copy of this order to the Board of Aldermen for the City of Branson, and to the County Commissions of the following Missouri counties: Pettis, Taney, Cass, Jasper, Moniteau, Barry, Stone, Jefferson, and Boone.

2. The Commission's Public Policy and Outreach Department shall make notice of this order available to the media serving the City of Branson, and also to the media serving the following Missouri counties: Pettis, Taney, Cass, Jasper, Moniteau, Barry, Stone, Jefferson, and Boone.

3. Any person wishing to intervene in this matter shall file an application to intervene no later than October 15, 2025. The application shall be filed in the Commission's Electronic Filing and Information System (EFIS) or with the Secretary of the Commission.

4. The Commission's Staff shall file a Recommendation, or a status report stating when it expects to file its Recommendation, no later than October 29, 2025.

5. This order shall be effective when issued.
