STAFF RECOMMENDATION AND RESPONSE TO COMMISSION ORDERS

COMES NOW Staff of the Missouri Public Service Commission and for this Staff Recommendation and Response to Commission Orders respectfully states as follows:

- 1. On June 19, 2023, Union Electric Company d/b/a/ Ameren Missouri (Ameren Missouri) filed tariff sheets designated as Tariff Tracking No. YE-2023-0222 that Ameren Missouri stated in its accompanying tariff filing letter were intended to reflect the Commission's June 14, 2023 *Report and Order*. Also on June 19, 2023, Ameren Missouri filed a Motion for Expedited Treatment and Approval of Tariff Sheets Filed in Compliance with Commission Order on Less Than Thirty Days' Notice, requesting expedited review and representing its intent to utilize a "bifurcated" compliance tariff process.
- 2. On June 20, 2023, Staff provided to Ameren Missouri and the Office of the Public Counsel (OPC) draft language intended to accomplish full compliance with the Commission's Report and Order dated June 14, 2023, effective June 24, 2023, without need for further compliance tariff submissions (i.e., the "bifurcated" process) as contemplated in Ameren Missouri's June 19 filing.
- 3. Staff, OPC, and Ameren Missouri engaged in brief discussion of the draft language and minor modifications related to clarifying certain dates associated with the residential time of use rate defaulting timeline and process. Ameren Missouri generally submitted the resulting language in part as tariff submission YE-2023-0227 on June 22, 2023, and as a substitute tariff filing on June 22, 2023 at approximately 10:40

am.¹ Additional issues were also addressed in this substitute filing. Further substitutes were made on June 22, 2023 at approximately 2:29 pm to specify that the default residential rate plan is "Option A" of the Smart Saver rate plan.

4 In the rates reflected in these tariff sheets, the allocation of revenue requirement to the classes as ordered by the Commission has been modified consistent with the provisions of Section 393.1655.6, RSMo, providing that any rate increase for the LPS class in excess of two percent shall be applied to all other customer classes by a uniform percentage adjustment. The date used for the calculation of the LPS cap was July 1, 2023. Therefore, in response to the Commission's June 20, 2023 Order Directing an Expedited Staff Tariff Recommendation and Setting Time for Tariff Responses and Objections to Tariff Sheets Becoming Effective on July 1, 2023, and the Commission's June 22, 2023 Order Directing an Expedited Staff Time-of-Use Tariff Recommendation and Setting Time for Time-of-Use Tariff Responses and Objections to Time-of-Use Tariff Sheets Becoming Effective on July 1, 2023, Staff supports issuance of a Commission order that all tariff sheets in submissions Tracking No. YE-2023-0222, as substituted and further substituted, and in Tracking No. YE-2023-0227 take effect on July 1, 2023.2 In fact, a different effective date for the tariff sheets could necessitate recalculation of the rates and resubmittal of the tariff sheets.

¹ On June 22, 2023 at approximately 1:00 pm the Commission ordered "Staff must file a recommendation about the time-of-use tariff sheets filed by Ameren Missouri no later than June 23, 2023, at 3:00 p.m. Staff's recommendation must also state whether Staff objects to the time-of-use tariff sheets taking effect on July 1, 2023. If Staff needs additional time to examine the time-of-use tariff sheets it shall inform the Commission no later than June 23, 2023, at 3:00 p.m."

² Staff notes that review of this tariff submission on the expedited timeline involved significant coordination internally and with Ameren Missouri, and that significant work preceded the June 19, 2023 tariff submission. This is consistent with the Staff's commitment found at page 2 of the April 7, 2023 *Stipulation and Agreement* to reasonably support effectuation of a July 1, 2023 tariff effective date in this manner.

5.
