## ORDER GRANTING MOTION FOR EXTENSION OF TIME

On December 1, 2022, Union Electric Company d/b/a Ameren Missouri filed a tariff to adjust the rate of its Energy Efficiency Investment Charge. Ameren Missouri's tariff sheet bears a February 1, 2023 effective date. The Commission ordered its Staff to submit its recommendation no later than January 4, 2023.

On January 4, 2023, Staff filed a Motion for Extension of Time. Staff explains that it needs additional time to obtain critical information from Ameren Missouri prior to submitting its recommendation, specifically regarding kWh saved and Ameren's explanation of their rebase adjustment.

The Commission finds Staff's motion reasonable, and will grant it.

### THE COMMISSION ORDERS THAT:

1. Staff's Motion for Extension of Time is granted.
2. The Commission's Staff shall file its recommendation no later than January 13, 2023.
3. This order shall be effective when issued.
