NOTICE OF DEFICIENCY

Issue Date: April 17, 2023

On April 4, 2022, the Commission issued its order directing Evergy Missouri West, Inc. d/b/a Evergy Missouri West (Evergy West) to file a tariff sheet to implement an interim adjusted Fuel Adjustment Rates based on the fuel and Purchased Poser Adjustment amount of \$18,755,192, until the Commission approves new Fuel Adjustment Rates. On April 17, 2023, Evergy West filed a proposed tariff sheet, Tracking No. YE-2023-0187, which is the Fuel and Purchased Power Adjustment for the Months of May 2023 through August 2023, with an effective date of May 1, 2023.

Section 393.140(11) requires that, unless the Commission otherwise orders, no tariff shall become effective except after thirty days' notice and publication. Evergy West's proposed tariff sheet provides less than 30-days' notice and publication, and the Commission has issued no order authorizing expedited treatment.

Commission Rule 20 CSR 4240-2.065(2) states that when a public utility submits a tariff for Commission approval, but requests the tariff to become effective in fewer than thirty days, the public utility shall file a motion for expedited treatment and comply with the expedited treatment portion of the Commission's rules.

The Commission will not take any action on Evergy West's proposed tariff sheet until a tariff sheet is filed in compliance with the Commission's rules.
