## ORDER FURTHER DELAYING PROCEDURAL DEADLINES

Effective Date: September 26, 2025

On September 25, 2025,<sup>1</sup> the Staff of the Commission (Staff) filed its *List of Issues and Motion for Extension for Order of Witnesses and Stipulation of Facts* (Motion) on behalf of the parties.<sup>2</sup> The Motion states that the parties agreed to request that the Commission further extend two procedural deadlines.

The requested deadline extensions are as follows:

- The Order of Witnesses was due on September 25. An extension is requested to Friday, September 26.
- The Stipulation of Facts was due on September 25. An extension is requested to Tuesday, September 30.

The Commission finds the Motion's requests to be reasonable and will grant them.

### THE COMMISSION ORDERS THAT:

1. The due date of the Order of Witnesses is changed to be filed no later than Friday, September 26.
