On September 15, 2025, the Staff of the Commission (Staff) filed its *Staff Recommendation* regarding the application of Ameren Transmission Company of Illinois (ATXI) in this matter.

On September 25, 2025, the Office of the Public Counsel (Public Counsel) filed a *Motion for Extension of Time* requesting an additional 29 days to respond to Staff's recommendation.

In its application, ATXI requested an order from the Commission by March 1, 2026. With that in mind, the Commission finds Public Counsel's motion reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. Public Counsel is granted an extension to October 24, 2025, to file a response to Staff's recommendation.
2. This order shall be effective when issued.
