Re: EC-2026-0004 — Brett Felber (Complainant) v. Ameren Missouri (Respondent)

To the Honorable Commissioners, Commission Staff, Regulatory Judge, and Ameren Missouri:

I write to place the Commission, Commission Staff, Regulatory Judge, and Ameren Missouri on formal notice regarding continuing issues I have observed in this matter. I believe there is a clear pattern of distortion, interchange, and manipulation of documents and communications by certain parties involved in this proceeding. These actions obstruct the administration of justice, impair the fact-finding process, and prejudice my rights as the complainant.

I would also like to add the following: I strongly recommend that any lying, manipulating tactics, or attempts to alter documents or testimony being employed against me immediately cease. I will not single out individuals here, but—be advised—the only party being fooled by such conduct is the party engaging in it. Continued manipulation of documents or communications will be documented, submitted to the record, and referred to all appropriate authorities as necessary.

For the record and to assist the Commission in its assessment of the authenticity and provenance of documents submitted in this case, I have used and continue to use multiple forensic analysis and counterfeit-document detection programs and devices. Below is a non-exhaustive list of widely used forensic and document-authentication tools (both hardware and software) that are commonly relied upon in questioned-document examination and identity/document verification workflows. I provide this list to help the Commission and Staff understand the methods and technologies I've relied on and to encourage the Commission to consider such tools and independent expert examination when assessing disputed exhibits.

- 2. ESDA (Electrostatic Detection Apparatus) detects indented writing on paper.
- 3. Regula Forensics document readers automated passport/ID/banknote scanners.
