## ORDER GRANTING APPLICATION TO INTERVENE

Issue Date: September 30, 2025 Effective Date: September 30, 2025

On August 29, 2025,<sup>1</sup> Union Electric Company d/b/a Ameren Missouri filed an application for a Certificate of Convenience and Necessity with the Commission to construct, install, own, operate, maintain and otherwise control and manage a solar generation facility in Callaway County, Missouri. Subsequently, the Commission set a time for applications to intervene.

On September 18, Sierra Club timely filed an application to intervene. Sierra Club stated that it is a non-profit organization whose purpose is to preserve and protect environmental values. Sierra Club stated its interests are different than those of the general public. Sierra Club further stated that granting its intervention request would serve the public interest. Sierra Club did not provide a position regarding the application but stated it expects to provide a position after reviewing the application further and forthcoming discovery.

More than ten days have passed since the filing of Sierra Club's application to intervene and no one has responded.<sup>2</sup> After considering the unopposed application to

intervene, the Commission finds that Sierra Club has interests which are different from that of the general public and also that allowing it to intervene will serve the public interest. Therefore, in accordance with Commission Rule 20 CSR 4240-2.075(3), the Commission will grant the application to intervene.

## THE COMMISSION ORDERS THAT:

- 1. The application to intervene of Sierra Club is granted.
- 2. This order shall be effective when issued.
